A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, DENYING/GRANTING THE APPEAL BY OWEN ON BEHALF OF THE PROPERTY OWNER, REPUBLIC, LLC, UPHOLDING/AMENDING/DENYING THE PLANNING BOARD'S DECISION TO APPROVE RESOLUTION NO. 2025-031, FILED JULY 24, 2025, EFFECTIVELY DENYING THE BPAS ALLOCATION FOR 510 SOUTHARD STREET, KEY WEST, FLORIDA FINDING THAT THE PLANNING BOARD'S DECISION WAS/WAS NOT ACCORDANCE WITH PROCEDURAL IN SUBSTANTIVE LAND DEVELOPMENT REGULATIONS AS WELL AS THE COMPREHENSIVE PLAN; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Commission considered the record upon which the City Planning Director rendered a decision, and provided an opportunity for presentation by the appellant and the City Planner; and

WHEREAS, City Code of Ordinances section 90-431(4) requires the concurring vote of no less than four members of the Commission to reverse or modify the order, requirement, decision or determination of the Planning Board.
