A RESOLUTION OF THE CITY COMMISSION OF THE OF KEY WEST, FLORIDA, APPROVING THE PROCUREMENT OF PUBLIC TRANSIT WEB-BASED PLANNING SOFTWARE FROM SOFTWARE, INC. ("REMIX"), AS DESCRIBED IN THE ATTACHED PROPOSAL, WITH A ONE-YEAR COMMITMENT TERM, IN AN AMOUNT NOT TO EXCEED \$60,000, ON A SOLE SOURCE BASIS AND IN THE BEST INTEREST OF THE CITY, PURSUANT TO SECTION 2-797(1) AND OF THE CODE OF 2-797(4)(b) ORDINANCES; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS, BUDGET TRANSFERS, ADJUSTMENTS OR AMENDMENTS, UPON CONSENT OF CITY ATTORNEY ; PROVIDING FOR EFFECTIVE DATE.

WHEREAS, Key West Code of Ordinances section 2-797(1) permits the purchase of goods and services without competition on a sole source basis under certain specified conditions; and

WHEREAS, the City finds that this Remix web-based software program will satisfy the City's needs, and that Remix is the sole source provider of this proprietary system; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the procurement of the web-based Remix Public Transit software for a one-year period, as set forth in the attached price quote from Remix, is hereby approved in an amount not to exceed \$60,000.00, pursuant to Code of

Ordinances Section 2-797(1) sole source procurement, and Section 2-797(4) (b), best interests of the City.

Section 2: The City Manager is authorized to effectuate any necessary budget transfers, budget amendments, project scope modifications, to enter into an agreement, and to execute any necessary documents, upon consent of the City Attorney.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
