A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RATIFYING AN EMERGENCY PROCUREMENT APPROVED BY THE CITY MANAGER IN THE AMOUNT OF \$20,000.00 AS ALLOWED UNDER SECTION 2-797 FOR AN AFTER-FACT INCREASE IN THE CONTRACT AMOUNT FOR CONSTRUCTION, ENGINEERING AND INSPECTION (CEI) SERVICES FOR THE CONTRACT APPROVED IN RESOLUTION 12-169 BETWEEN THE CITY AND AMEC ENVIRONMENT & INFRASTRUCTURE, INC., FOR THE POINCIANA SAFE ROUTES TO SCHOOL SIDEWALK INSTALLATION PROJECT IN THE AMOUNT OF \$20,000.00; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 12-169, the City Commission approved a contract with AMEC Environment & Infrastructure, Inc., for CEI services, pursuant to a LAP agreement and subsequent supplemental agreements, for the Poinciana Elementary Safe Routes to School sidewalk installation project; and

WHEREAS, the contract has insufficient funds to pay for the amount of construction observation necessary to complete the project, and the City Manager, utilizing emergency powers authorized under Section 2-797(2) of the City's Code of Ordinances, acted to approve a necessary contract increase in the amount of \$20,000.00; and

WHEREAS, Section 2-797(2) of the City's Code of Ordinances requires the City Commission to ratify such emergency procurements at its next scheduled meeting.

WHEREAS, additional funds are authorized for this contract in the LAP Supplemental Agreement #3, approved by the City Commission at the August 6, 2013 meeting; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: : The City Commission in accordance with Section 2-797(2) of the City of Key West Code of Ordinances, hereby ratifies the City Manager's emergency authorization for a procurement in the additional amount of \$20,000.00 from AMEC Environment & Infrastructure, Inc. for the CEI services contract approved in Resolution No. 12-169.

Section 2: That necessary budget transfers are authorized.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the

signature of the presiding officer and the Clerk of the Commission.
