

RESOLUTION NO. 23-267

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING KEY WEST PORT OPERATIONS, WITH THE KEY WEST POLICE DEPARTMENT, TO ACCEPT GRANT AWARD NO. EMW-2023-PU-00396-S01 IN THE AMOUNT OF \$944,819.00 FROM THE DEPARTMENT OF HOMELAND SECURITY PORT SECURITY GRANT PROGRAM (PSGP) (CITY MATCH \$314,940.00) FOR ACQUISITION OF A MOBILE COMMAND CENTER AND MOBILE CONNECTIVITY TRAILER; APPROVING A TRANSFER OF \$314,940.00 FROM KEY WEST BIGHT RESERVES; APPROVING NECESSARY BUDGET AMENDMENTS AND TRANSFERS TO ACCEPT THE FUNDING; PROVIDING FOR AN EFFECTIVE DATE

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the Key West Port, with the Key West Police Department, via direction to the City Manager, is authorized to accept grant award NO. EMW-2023-PU-00396-S01 in the amount of \$944,819.00 (City match \$314,940.00) for acquisition of a mobile command center and mobile connectivity trailer.

Section 2: That grant revenue will be budgeted in account 001-0000-331-2000 (General Fund/Revenue/Public Safety) in FY23/24. Expenses, including city matching funds for this grant will be

budgeted in account 001-2104-521-6400 (General Fund Law Enforcement Grants/Machinery and Equipment). A transfer of \$314,940.00 for the City's 25% match from Key West Bight reserves is hereby approved. Any necessary budget adjustments and transfers are hereby authorized.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
