## RESOLUTION NO.

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AWARDING THE ROOF ESTIMATE PRICE QUOTE FROM A+ ROOFING KEY WEST, INC. IN THE AMOUNT OF UP TO \$80,000.00 FOR ROOF REPAIR SERVICES AND RELATED TASKS, INCLUSIVE OF UNFORESEEN COSTS, AT THE KEY WEST TRANSIT FACILITY ON COLLEGE ROAD ON A SOLE SOURCE BASIS PURSUANT TO SECTION 2-797(1) OF THE CODE OF ORDINANCES; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City requested price quotes for the roof repair project, and A+ Roofing was the sole responsive respondent; and

WHEREAS, Key West Code of Ordinances section 2-797(1) permits the purchase of goods and services without competition on a sole source basis under certain specified conditions; and

WHEREAS, in Resolution 23-077, the City Commission accepted an FDOT grant for Transit Corridor Development Program Assistance in the amount of up to \$80,000.00 for Key West Transit Facility Roof Repair (Contract G2H33/FM#452677-1-94-01); and NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

<u>Section 1</u>: That the attached Roof Estimate Price Quote for A+ Roofing Key West, Inc. for roof repair services at the Key West Transit Facility on College Road is hereby awarded in an amount not to exceed \$80,000.00, inclusive of any unforeseen costs.

Section 2: This Task Order will be paid from account 4114404 5444600 (Project No. TS44042301 5444600). This project will be paid using the FDOT Transit Corridor Development Program Grant funding accepted pursuant to Resolution 23-077 and any necessary budget transfers or adjustments are hereby authorized.

<u>Section 3</u>: That the City Manager is authorized to execute any necessary documents, upon the advice and consent of the City Attorney. Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
