A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST (CITY) APPROVING CHANGE ORDER 4 TO CHARLEY TOPPINO & SONS, INC. IN A TOTAL AMOUNT NOT TO EXCEED \$150,686.90 FOR THE UNITED STREET **IMPROVEMENTS** PROJECT; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS AND AMENDMENTS; AUTHORIZING THE MANAGER EXECUTE CITY TO NECESSARY DOCUMENTS UPON ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution 23-057, the City Commission awarded ITB #23-003 for the United Street Improvements Project, to provide paving, Americans with Disabilities Act (ADA) sidewalks and curb ramps, bike lanes, pavement markings, and landscaping along United Street from Whitehead Street to Grinnell Street to Charley Toppino & Sons, Inc.; and

WHEREAS, City staff were contacted by the Florida Keys Aqueduct Authority (FKAA) for help to complete paving of road surfaces on William, Royal, and Elizabeth Streets along United Street by using the City contractor, whereupon FKAA would reimburse the City for associated costs.; and

WHEREAS, City Staff identified areas along United Street between Simonton and Whitehead Streets to be too flat to hold drainage slope tolerances, needing the addition of approximately 795 LF of concrete valley gutter to maintain acceptable grades to allow proper drainage.; and

WHEREAS, the Utilities Department requested that work at at Whitehead Street be held off to allow future drainage improvements to be installed at the intersection.

NOW, THEREFORE, BE IT RESOLVED BY CITY COMMISSION OF THE CITY OF KEY WEST FLORIDA, AS FOLLOWS:

Section 1: That the attached Change Order 4 in the amount of \$150,686.90 under the contract awarded to Charley Toppino and Sons, Inc. (ITB 23-003) in Resolution 23-057, for the United Street Improvements project is hereby approved.

Section 2: That funds for Change Order 4 are allocated in account #102-4102-541-6300 (Internal Improvements/Gas Tax), Project #II41022302.

Section 3: That the City Manager is authorized to execute documents related to Change Order 4, upon the advice and consent of the City Attorney. That this Resolution shall go into effect Section 4: immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
