A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE 60-MONTH LEASE OF A DUNCAN SOLUTIONS MOBILE COMPUTERS (PARKING CITATION HANDHELDS) PLUS ACCESSORIES IN AN AMOUNT NOT TO EXCEED \$28,512.00 PER YEAR (\$2,376.00/MONTH FOR A 60 MONTH TERM, PLUS SUPPLIES) PURSUANT TO SECTION 2-797(4)(b) OF THE CODE OF ORDINANCES; AUTHORIZING THE CITY MANAGER TO EXECUTE A LEASE IN CONFORMANCE WITH THE TERMS CONTAINED IN THE PRICE QUOTE, UPON THE CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Section 2-796 of the Code of Ordinances requires competitive bidding for purchases or services in excess of \$20,000.00; and

WHEREAS, City staff has been using Duncan Solutions handheld equipment for a number of years with satisfactory results, and has identified a need to replace and upgrade the equipment and software used for issuing parking citations; and

WHEREAS, Key West Code of Ordinances section 2-797(4)(b) further provides "If in the opinion of the city manager exceptional circumstances exist to exempt a purchase from the competitive bid requirements of this subdivision for the best interests of the city, he shall place a resolution before the city commission for approval of such exemption."; and

WHEREAS, the City Manager has recommended the waiver of formal bidding procedures pursuant to section 2-797(4) of the Code of Ordinances; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the expenditure of funds in an amount not to exceed \$28,512.00 per year to Duncan Solutions, for a 60-month lease of equipment, is hereby approved pursuant to section 2-797(4) of the Code of Ordinances.

Section 2: That the City Manager is authorized to execute a lease in conformance with the terms contained in the price quote, upon consent of the City Attorney.

Section 3: That this lease is budgeted for FY 14-15 in account 001-1206-512-4400.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
