

RESOLUTION NO. 19-220

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FOR A SAMUELS HOUSE, INC. FUNDRAISER AT THE SOUTHERNMOST HOUSE 1400 DUVAL STREET DURING THE HOURS OF 7:00 P.M. TO 10:00 P.M. ON SATURDAY, SEPTEMBER 14, 2019; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Section 6-86 of the Key West Code of Ordinances requires a Special Event Permit to depart from the requirements of the City's Noise Control Ordinance; and

WHEREAS, Samuels House, Inc, has applied to the City for a Special Event Permit for an event to take place on Saturday, September 14, 2019 from 7:00 p.m. to 10:00 p.m.

WHEREAS, this event shall take place at the Southernmost House at 1400 Duval Street.

WHEREAS, amplified music will be played during the event;

NOW THEREFORE, BE IT RESOLVED by the City Commission of the City of Key West, Florida:

SECTION 1. That Samuels House, Inc. is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place at the place and time as herein described.

SECTION 2. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.


