Tree Species: Bottlebrush (Calistemon sp.)

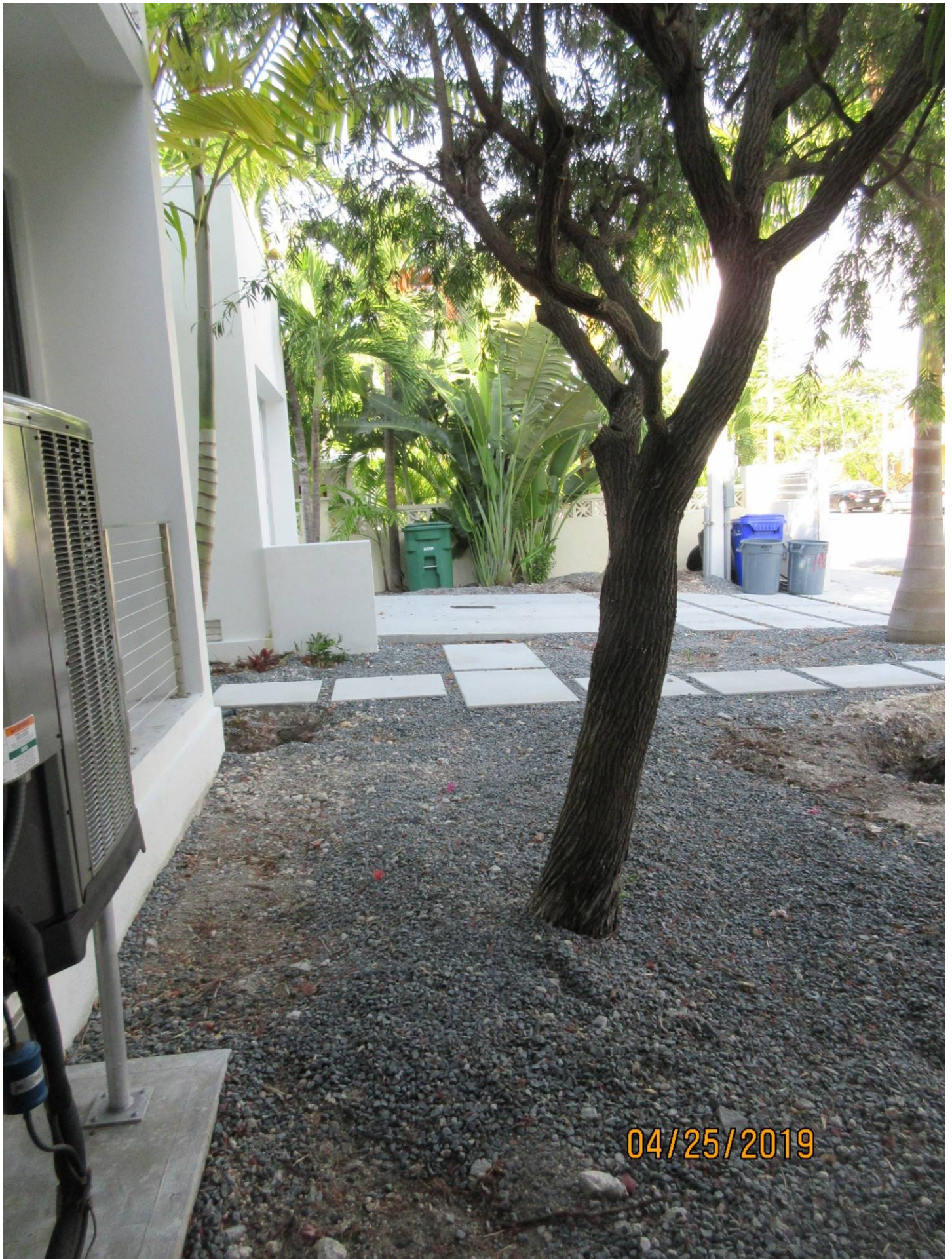
