A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE KEY WEST ROTARY CLUB FOUNDATION, INC. THE USE OF BAYVIEW PARK AND A BIKE RIDE THROUGH THE STREETS OF KEY WEST ON FRIDAY, MAY 29, 2015, FROM 5:30 P.M. TO 9:00 P.M.; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; GRANTING AN EXEMPTION FROM THE NOISE CONTROL ORDINANCE PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES DURING THE EVENT; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES DURING THE EVENT; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Key West Rotary Club Foundation, Inc. wishes to conduct a fundraiser at the Bayview Park & Bike Ride through the streets of Key West between the hours of 5:30 p.m. to 9:00 p.m. on Friday, May 29, 2015; and

WHEREAS, this event shall take place at Bayview Park between the hours of 5:30 p.m. to 9:00 p.m. on May 29, 2015; and

WHEREAS, the sponsor anticipates that amplified music will be played during the event;

NOW, THEREFORE, BE IT RESOLVED, by the City Commission of the City of Key West, Florida;

SECTION 1. That the Key West Rotary Club Foundation, Inc. is hereby granted permission to conduct an event on the date and during the hours stated above;

PROVIDED all trash is adequately collected and contained; guarantee indemnifying the City is executed; and provided the organizations meet the terms and conditions set forth by the City Manager.

SECTION 2. That the Key West Rotary Club of Key West, Florida, Inc. is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place at the place and time herein described.

SECTION 3. That pursuant to the City of Key West Code of Ordinances, Section 18-86, the consumption of alcoholic beverages is permitted within the barricaded areas of the event.

SECTION 4. That any use of the Truman Waterfront properties should be coordinated and approved through the Local Redevelopment Agency Office.

SECTION 5. That the Key West Rotary Club of Foundation, Inc. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

SECTION 6. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
