A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, DIRECTING THE CITY MANAGER TO TAKE ALL NECESSARY STEPS TO CONSTRUCT A NEW FIRE STATION ON THE FORMER MADELINE BEAN BUILDING SITE AND CONTINUE TO UTILIZE THE STATION AT 525 ANGELA STREET UNTIL COMPLETION OF THE NEW FIRE STATION; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, pursuant to City Commission Resolution 09-058, the City Commission selected 525 Angela Street as the location of a new City administration facility, which includes parking, a fire station and City Hall; and

WHEREAS, regardless of the location of City Hall, a new fire station and parking facilities will be built at the 604 Simonton/525 Angela Street location; and

WHEREAS, the Madeline Bean Building has been demolished and the site is appropriate for the construction of the new fire station; and

WHEREAS, the City can continue to utilize the current fire station at 525 Angela Street while a new station is expeditiously constructed on the site of the former Madeline Bean Building; and

WHEREAS, the remainder of 525 Angela Street building former utilized as City Hall can provide an invaluable tool for police and fire training until such time as it is demolished upon construction of the new fire station; and
