A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AWARDING THE BID OF CHARLEY TOPPINO AND SONS, INC. FOR RIGHT OF WAY IMPROVEMENTS 2022, ACCORDANCE WITH THE TERMS SPECIFIED IN ITB 22-010, INCLUDING UNIT PRICING (A TOTAL AMOUNT NOT TO EXCEED MULTI-YEAR BUDGETED FUNDS); AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT IN SUBSTANTIAL CONFORMANCE WITH THE CONTRACT DOCUMENTS CONTAINED IN THE BID PACKAGE ON A TASK ORDER BASIS AND UPON ADVICE AND CONSENT OF THE CITY ATTORNEY; AUTHORIZING ANY **NECESSARY** BUDGET TRANSFERS AND ADJUSTMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on November 16, 2022, one bid was opened in response to ITB #22-010, for Right-of-Way Improvements 2022, and the bid was determined to be responsive; and

WHEREAS, City staff recommends award of bid to Charley Toppino & Sons, Inc., and that individual work orders will be issued by City staff and approved by the City Manager for the selected project locations.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the bid of Charley Toppino and Sons, Inc. for Right-of-Way Improvements in accordance with the terms specified in ITB #22-010 is hereby accepted, on a task-order/unit pricing basis, in an amount not to exceed budgeted funds for City paving-related projects in FY 22-23 and subsequent years.

Section 2: That the City Manager is authorized to execute a contract in substantial conformance with the contract documents contained within the bid package on behalf of the City of Key West, upon the advice and consent of the City Attorney.

Section 3: That any necessary budget transfers or adjustments are hereby authorized within the City's paving related project budgets, including ADA Compliance Sidewalk and Intersection (II41022301), City-wide Paving Program (II41022302), and the Shoulder Restoration Program (II41022303) account.
