A RESOLUTION OF THE CAROLINE STREET CORRIDOR AND BAHAMA VILLAGE COMMUNITY REDEVELOPMENT AGENCY (CRA) AWARDING THE BID OF GEMSTONE RDI JV IN RESPONSE TO ITB #25-003 IN A TOTAL AMOUNT NOT TO EXCEED \$1,045,700.00 FOR SCHOONER WHARF FLOATING DOCKS REPLACEMENT (KB75031802) AT THE KEY WEST BIGHT MARINA; WAIVING MINOR IRREGULARITIES; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS OF ADJUSTMENTS ; AUTHORIZING CITY THE MANAGER TO EXECUTE NECESSARY DOCUMENTS IN CONFORMANCE WITH THE BID DOCUMENTS, UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, three responsive bids were opened on February 6, 2025, in response to ITB #25-003, and staff recommends award of bid to the lowest responsive bidder, Gemstone RDI JV; and

WHEREAS, the Key West Bight Management District Board, in Resolution KWBB 25-04, recommended that the CRA award of the bid for Schooner Wharf Floating Docks Replacement to Gemstone RDI JV; and

NOW, THEREFORE, BE IT RESOLVED BY THE CAROLINE STREET CORRIDOR AND BAHAMA VILLAGE COMMUNITY REDEVELOPMENT AGENCY, AS FOLLOWS: Section 1: That the bid of Gemstone RDI JV is hereby awarded in an amount not to exceed \$1,045,700.00, in response to ITB #25-003, for Schooner Wharf Floating Docks Replacement at the Key West Bight Marina, the terms and conditions of which are incorporated herein.

<u>Section 2</u>: That minor irregularities or informalities in the bid proposal are waived.

Section 3: That funding for this project is budgeted in Infrastructure Fund Account 405-7503-575-6300 (Project No. KB75031802), and any necessary budget transfers or adjustments are hereby approved.

<u>Section 4</u>: That the City Manager is authorized to execute any necessary documents, in conformance with the bid documents, upon the advice and consent of the City Attorney. Section 5: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Agency.
