A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST (CITY) APPROVING A CHANGE ORDER (#5) IN THE AMOUNT OF \$27,000.06 FOR THE FREDERICK DOUGLASS COMMUNITY CENTER PROJECT, UNDER THE CONTRACT AWARDED TO KEYSTAR INC. IN RES #23-193; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS AND AMENDMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS UPON ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 23-193 a contract was awarded to Keystar, Inc. for the Frederick Douglass Community Center Project, in the original amount of \$7,985,927.86 in response to ITB #23-005; and

WHEREAS, the City Commission has approved prior change orders in Resolution Nos. 24-024, 24-114, and 24-115; and

WHEREAS, City staff recommends approval of the change order, which will bring the total project cost to \$8,532,354.83; and

NOW, THEREFORE, BE IT RESOLVED BY CITY COMMISSION OF THE CITY OF KEY WEST, AS FOLLOWS:

Section 1: That the attached Change Order (#5) in the amount of \$27,000.06 for additional amendments to the Frederick Douglass Community Center, under the contract awarded to Keystar, Inc. (ITB 23-005) in Resolution 23-193, is hereby approved.

Section 2: That funds for this change order will be used from account #601-5502-555-6200 (Project BV55021701) (CRA Bahama Village Capital Improvements). Any necessary budget transfers or amendments are hereby authorized.

Section 3: That the City Manager is authorized to execute documents related to this Change Order, upon the advice and consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
