A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, ACCEPTING PURSUANT TO SECTION 2-797(4) OF THE CODE OF ORDINANCES THE PROPOSAL OF OWENS OIL COMPANY TO PROVIDE DIESEL FUEL IN AN AMOUNT NOT TO EXCEED \$150,000.00 FOR CITY VEHICLES ON AN AS-NECESSARY BASIS DURING THE RELOCATION OF FUEL TANKS TO THE NEW TRANSIT FACILITY; ADDITIONALLY ACCEPTING THE PROPOSAL OF DIONS EXXON/MOBIL TO PROVIDE DIESEL FUEL IN AN AMOUNT NOT TO EXCEED \$150,000.00 DURING THE RELOCATION OF FUEL TANKS TO THE NEW TRANSIT FACILITY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Section 2-796 of the Code of Ordinances requires competitive bidding for purchases or services in excess of \$20,000.00; and

WHEREAS, the City anticipates that the Key West Transit fuel tank and fueling station will be unusable for up to twelve (12) weeks, commencing in July, 2015, while the tank is relocated to the new Key West Transit Facility; and

WHEREAS, City staff obtained proposals including fleet pricing and policies from two local vendors with facilities capable of providing diesel fuel services to City vehicles; and

WHEREAS, City staff reviewed the proposals and recommends approval and acceptance of the proposal from Owens Oil Company, and approval of the proposal of Dions located 3228 Flagler Avenue, as an secondary vendor, to ensure uninterrupted services at all times; and

WHEREAS, the City Manager finds that pursuant to section 2-797(4), it is in the best interest of the City to authorize an expenditure not to exceed \$150,000.00 for diesel fuel supplies and service from Owens Oil and/or Dions on Flagler Avenue, during the construction of the fuel station at the new City Transit Facility.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the proposal of Owens Oil Company to provide diesel fuel for City vehicles on an interim basis during the installation of fuel services at the new Key West Transit Center, is hereby approved in an amount not to exceed \$150,000.00, pursuant to section 2-797(4) of the Code of Ordinances.

Section 2: That the proposal of Dions (Exxon/Mobil), located at 3228 Flagler Avenue, to provide diesel fuel for City vehicles on an interim basis during the installation of fuel services at the new key West Transit Center, is hereby approved in an amount not to exceed \$150,000.00, pursuant to section 2-797(4) of the Code of Ordinances.

Section 3: That the Transit Department is directed to closely monitor fuel purchases while the City's fuel station is out of service, and to pay expenses on a monthly basis.

Section 4: That the cost of diesel fuel is included in the FY 14-15 budget.

Section 5: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
