A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE ATTACHED "MEMORANDUM OF UNDERSTANDING BETWEEN STATE OF FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION, DIVISION OF RECREATION AND PARKS AND CITY OF KEY WEST FLORIDA - FORT ZACHARY STATE PARK"; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in 1984, the US Dept. of the Navy and the Florida Division of Recreation and Parks entered into an agreement in order for the US Navy to provide an easement to the state for the construction, installation, operation, maintenance, repair and replacement of a road and contact station for access to Fort Zachary Taylor"; and

WHEREAS, the easement survived the transfer of a portion of the former US Navy Property to the City in 2002, and additionally a portion of former US Navy Lands near the entrance to the Outer Mole was given to the State of Florida for a future access point Fort Zachary Taylor, so that after development of the Truman Waterfront Park, there would no longer be a portion of the state park access road on US Navy property; and

WHEREAS, in order to plan and provide for orderly construction of the Truman Waterfront Park main access road, the new state entry to Fort Zachary Taylor, and the entry control point for the Navy's Outer Mole Pier, the attached Memorandum of Understanding between the City and the State of Florida is necessary to coordinate work on state and City lands;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the attached "Memorandum of Understanding Between State of Florida Department of Environmental Protection Division of Recreation and Parks and City of Key West - Fort Zachary Taylor Historic State Park" is hereby approved.

Section 2: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
