- REVOCABLE LICENSE 2022-23

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE CITY OF KEY WEST TO ENTER INTO THE ATTACHED "REVOCABLE LICENSE AGREEMENT FOR NONPERMANENT USE OF CITY PROPERTY" WITH JILL SNODGRASS (DBA DAILY PLAN-IT), TO ALLOW THE OPERATION OF AN ARTISAN MARKET AT INDIGENOUS PARK (1801 WHITE STREET) ON DATES SET FORTH IN THE AGREEMENT, UPON ADDITIONAL TERMS AND CONDITIONS CONTAINED IN THE AGREEMENT (OCTOBER 23, 2022-APRIL 24, 2023); PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Section 2-939 of the Code of Ordinances of the City of Key West, Florida allows the City to grant a revocable license for a nonpermanent use of City property; and

WHEREAS, the City Commission finds that a regularly scheduled Artisan Market provides local access to fresh foods, handcrafts and related merchandise, and thereby provides a benefit to residents and visitors;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Manager is hereby authorized to execute the attached "Revocable License Agreement for Use of City Property" (the "Agreement") between the City and Jill Snodgrass

(dba Daily Plan-It) for the use of a designated area of Indigenous Park (1801 White Street) for an Artisan Market, on dates set forth in Exhibit "B", upon specific terms and conditions set forth in the Agreement (October 23, 2022-April 24, 2023).

Section 2: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
