A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE ATTACHED LEASE AGREEMENT BETWEEN THE CITY AND THE BAHAMA VILLAGE MUSIC PROGRAM, INC., A FLORIDA NOT FOR PROFIT CORPORATION, FOR USE OF A PORTION OF 103 OLIVIA STREET FOR A MUSIC EDUCATION PROGRAM, AT BELOW MARKET RENT FOR PUBLIC BENEFIT, PURSUANT TO SECTION 2-941(c) OF THE CODE OF ORDINANCES; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, construction on the Frederick Douglass Community Center is nearing completion, and the Bahama Village Music Program will occupy a portion of the new Community Center, as it did occupy the Frederick Douglass complex prior to demolition and reconstruction; and

WHEREAS, the City Commission finds that occupancy of the premises by the Bahama Village Music Program, Inc., a not for profit corporation, which provides music education and mentorship for local youth, pursuant to the terms and conditions set forth in the attached lease agreement, would provide a valuable public benefit and is otherwise consistent with City Code of Ordinances section 2-941(c).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

<u>Section 1</u>: That the attached five-year lease agreement between the City and the Bahama Village Music Program, Inc. for use of a portion of 103 Olivia Street, the Frederick Douglass Community Center, is hereby approved at below market rent, as a public benefit pursuant to City ordinance section 2-941(c).

<u>Section 3</u>: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
