Narrative

NARRATIVE OF INCIDENT

Officers responded to Sloppy Joes, located at 201 Duval Street, in reference to a battery. Officer Christina spoke with the bar management. The subject, who was outside on the sidewalk, refused to comply with Officer Christina's order to stop impeding his investigation. The subject attempted to regain entrance to the bar via the side door. The subject refused to cooperate with Officer Christina's orders as he tried to continue his investigation.

The subject physically made evasive movements to defeat the officer's actions as he tried to handcuff her. Officer Christina conducted a leg sweep and was able to take the subject to the ground, where she was handcuffed. Officer Christina and Officer Gruba stood her up as they were adjusting her handcuffs. The subject's aggressiveness escalated, and she kicked Officer Christina in the genitalia. Officer Gruba assisted Officer Christina in taking the subject back to the ground and they were able to control her.

Officer Gruba and Officer Martinez put the subject in an escort position and transported her to a patrol car; as Officer Martinez was searching for the subject incident to arrest, she again resisted and kicked Officer Gruba in the chest. The subject also attempted to kick Officer Martinez in the genitalia. His evasive move made the kick strike his upper thigh.

Officer Martinez and Officer Gruba took the subject to the ground in a controlled manner, where she could be controlled. and hobled to stop her kicking. She was then put into the patrol car without further incident.

I met with the subject. Both of her thighs appeared to have dirt on them. She did not have any injuries.

-- Haydy Demetria Rodriguez Cobian Arrest Narrative: On 08/10/2024 at approximately 0204 Hours, I (Ofc. D. Christina 4415) was dispatched to 201 Duval St (Sloppy Joe's Bar) in regard to a battery.

Upon my arrival, I met with the manager Meghan Baker, a white female, born on 01/13/1985 who stated the following. A party later identified as Haydy D. Rodriguez Cobian, a hispanic female, born on 11/26/1983 had been dancing, while dancing with unknown females she was asked to move away from them by said females. Cobian became upset and started an altercation with the females, security personnel Ian Jefferson, a black male, born on 11/08/1996 and Ron Levi, a white male, born on 05/12/1972 became aware of the altercation and asked Cobian to leave. Cobian begins an altercation with both Levi and Jefferson. Levi and Jefferson then escorted Cobian out of the Bar through the front doors. While escorting her out she bit Jefferson on the arm and scratched Levi on the hand, drawing blood on both parties.

While Levi and Baker were trying to explain the events to me, Cobian continued to try to enter the bar through a side door we were standing at. When I instructed her to step back so that I could conduct my investigation she became aggressive with me. I advised her that if she did not step back, she would be placed into handcuffs so that I could conduct my investigation. She continued to approach me. I then told Cobian to put her hands behind her back grabbing her right wrist in the process, she began to pull away and resist. Because of her continued resistance, I guided her to the ground in a controlled descent, where I could safely handcuff her properly. Cobian continued to resist, by pushing and pulling both arms to prevent placing her into handcuffs. Once into handcuffs, she was lifted to her feet, where it became apparent that during her resistance the strap to her purse had become entangled in the handcuffs. While trying to free the purse strap from the handcuffs and due to it being interlaced in them, she was able to slip her left hand free of the cuffs. Cobian then turned using her knee to strike me in the testicles. I then used a leg sweep technique forcing her to the ground in an uncontrolled manner where the handcuffs were re-secured.

Cobian was picked up and placed into an escort position by Ofc. J. Gruba, and Ofc. J. Ramos due to being in extreme pain from the knee strike to my testicles, and she walked to Ofc. Gruba's patrol vehicle. Once at the patrol vehicle, a search incident to arrest was conducted. During this time Cobian then started to kick again, she first attempted to kick Ofc. Ramos in the testicles however he was able to shift his body in time, and she struck him in the upper thigh/ pelvis region, Cobian then "spartan kicked" Ofc Gruba in his gut, where she was taken to the ground again to secure her feet. Cobian was then placed in the back of the patrol vehicle and transported to Monroe County Jail for processing.

It should be noted that Sgt M. Del Velle was notified and responded to the scene.

Once Cobian was in custody I continued the investigation speaking to Baker, Jefferson, and Levi to which all parties involved stated that they did not wish to aid in prosecution just that they wished for Cobian to be trespassed from the property.

Based on the facts and evidence, I believe there is probable cause that on 08/10/2024, Haydy D. Rodriguez Cobian did knowingly and intentionally violate F.S.S. 784.07-2B Battery on LEO, by actually and intentionally kneeing me in the testicles while struggling to pull her hands from me as I was handcuffing Cobian, while I was engaged in my legal, lawful duties as a uniformed law enforcement officer.

Based on the facts and evidence, I believe there is probable cause that on 08/10/2024, Haydy D. Rodriguez Cobian

did knowingly and intentionally violate F.S.S. 784.07-2B Battery on LEO, by actually and intentionally kicking Ofc. J. Ramos while struggling during the search of Cobian, while he was engaged in his legal, lawful duties as a uniformed law enforcement officer.

Based on the facts and evidence, I believe there is probable cause that on 08/10/2024, Haydy D. Rodriguez Cobian did knowingly and intentionally violate F.S.S. 784.07-2B Battery on LEO, by actually and intentionally kicking Ofc. J. Gruba while struggling during the search of Cobian, while he was engaged in his legal, lawful duties as a uniformed law enforcement officer.

Based on the facts and evidence, I believe there is probable cause that on 08/10/2024, Haydy D. Rodriguez Cobian did knowingly and intentionally violate F.S.S. 843.01 Resisting with Violence, by actually and purposely threatening to and initiating a physical altercation with Ofc. Ramos, Ofc. Gruba and me, while kicking and striking all while we were engaged in our legal, lawful duties as uniformed law enforcement officers.

My BWC was active for this encounter as well as transport.

On 08/10/2024, at approximately 0100 hours, Ofc. Christina and I, Ofc. Gruba, were dispatched to 201 Duval St, Sloppy Joes Bar, reference a female who bit a bouncer and was refusing to leave.

Upon arrival, I saw Ofc. Christina attempting to detain a female (Rodriguez) that was pulling away from him. When I walked up the two were on the ground. I assisted Ofc. Christina in getting Rodriguez in handcuffs. Rodriguez was pulling her left arm under her torso, making it hard for me to grab it. I eventually maneuvered her arm out from underneath her and into the handcuffs.

Ofc. Christina and I picked Rodriguez up and attempted to bring her over to my patrol vehicle. Rodriguez somehow slipped out of one of the cuffs and kicked Ofc. Christina in the genitals. Ofc. Christina escorted Rodriguez to the ground and secured Rodriguez's hands behind her back. Myself and Ofc. Ramos got Rodriguez to stand up and brought her over to my patrol car. While trying to put Rodriguez into my patrol car, Rodriguez kicked Ofc. Ramos in the legs and kicked me square in the stomach. Rodriguez was brought to the ground again. Ofc. Davis and myself picked Rodriguez up and placed her into the back of my patrol vehicle.

I transported Rodriguez to Monroe County Jail.

My BWC and Axon Fleet were activated during this incident.
