Staff Analysis

On April 11, 2012 the Commission approved a specific banner design and their location, as they were approved by the City Commission. On November 20, 2012 the applicant requested to the City Commission additional new locations for the banners. During that meeting the City Commission approved with condition the proposed additional locations, Front and Greene Streets and 400 block of Whitehead Street. The Commission approved the request with the condition that the sponsor's logo should not be prominent and be located on the lower portion of the banner.


The applicant has explained to the City Commission and to staff that the "historic nuggets" or historic information containing on all signs will vary in size, depending on the amount of words. The applicant is submitted a revised design as requested by the City Commission. This new revision will not require a second review from the City Commission, but must meet their recommendations.

The new design depicts the sponsor's name or logo on the bottom of the banner and will not exceed 6.3" in height. Staff understands that the sponsor's name or logo should be uniform in height; this will allow the center of the space free for the historic information, which is the most important part of the banner.

Consistency with Guidelines and Ordinance

- 1. The City Commission authorized the installation of banners on city light posts over city sidewalks.
- 2. The applicant has corrected the design problem that made the City Commission approval a conditional one. The sponsor's name or logo will be no taller than 6.6" and will be located on the bottom of the banner.
- 3. The banners will have 8' clearance from the sidewalk, as required by the Land Development Regulations and letters will not exceed 12" height.

It is staff's opinion that the proposed design is consistent with the guidelines.







