A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING KEY WEST PROMOTIONS, INC. TO CONDUCT A SEAFOOD LOBSTER FESTIVAL ON SATURDAY, AUGUST 14, 2021, FROM NOON TO 10:00 P.M, (STREET CLOSURE FROM 10:00 A.M. TO MIDNIGHT (SET UP & TEAR DOWN); PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE CLOSURE OF THE 100 , 200, 300 & 400 & 500 BLOCKS OF DUVAL STREET BETWEEN FRONT AND SOUTHARD STREETS INCLUDING THE GREENE STREET INTERSECTION AND TELEGRAPH LANE & CHARLES STREET FROM 10:00 A.M. TO MIDNIGHT; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Key West Promotions, Inc. wishes to conduct a Seafood Lobster Festival fundraiser for the Key West High School Scholarship Fund;

WHEREAS, other bars participating in the liquor extension are: Rick & Durty Harry's, Bagatelle, Hog's Breath, Conch Shack, Amigo's, Captain Tony's, Tiki House, The Green Room, Sand Bar, Scars and Tattoos, Sloppy Joe's, Irish Kevins, Stinkin Crawfish Key West, Lucy's Retired Surfer's Bar, Fogarty's, Smokin Tuna Saloon, Teasers, The Bull, Caroline's, The Grand, Fat Tuesday, Hard Rock Café, the La Concha Hotel, Jack Flats, Willie T's, La Trattoria, Margaritaville, Mary Ellen's.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Key West, Florida;

SECTION 1. That in Resolution 19-174, the City Commission directed the City Manager to "develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the local government for the provision of good or services, unless such use is otherwise preempted by law"

SECTION 2. “That the vendor/lessee/licensee acknowledges the City’s concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor therefore commits to refrain from the use of polystyrene/plastic straws, bags, plastic utensils and “to go” packages for food or products sold on any property leased from the City”

SECTION 3. That Key West Promotions, Inc. is hereby granted permission to conduct a Seafood Lobster Festival on the day and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meet the terms and conditions set forth by the City Manager; and that 25% shall be donated to the Key West High School Scholarship Fund.

SECTION 4. That Key West Promotions, Inc. is hereby granted permission for the closure of Duval Street between Front and Southard Streets and including Greene Street between Ann and Telegraph Lane & Charles Street on the date and during the hours stated above.

SECTION 5. That pursuant to Section 18-86 of the Key West Code of Ordinances, Key West Promotions, Inc. is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.

SECTION 6. That Sloppy Joe’s must post the required notice regarding prohibition of purchase and sale of alcoholic beverages to persons under 21 years of age.

SECTION 7. That the applicant acknowledges this authorization may be revoked by the Commission or the City Manager, due to exigent circumstances such as the resurgence of COVID-19 in the community.

SECTION 8. That Key West Promotions, Inc. will adhere to the recycling plan of the

City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

SECTION 9. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
