A regular meeting of the City Commission of the City of Key West, Florida was held in Commission Chambers, Old City Hall, on Wednesday, October 2, 2013.

Mayor Craig Cates called the meeting to order at 6:00 p.m.

Answering roll call were Commissioners Teri Johnston, Clayton Lopez, Billy Wardlow, Jimmy Weekley, Tony Yaniz and Mayor Craig Cates.

Commissioner Mark Rossi was absent.

Pastor Charles Elliott, Eagle's Rest Christian Center, gave the invocation.

PRESENTATIONS:

City Attorney's Report

City Attorney Shawn Smith had no report for the Commission. Commission Weekley asked the City Attorney about amending the Comprehensive Plan regarding protection of our waters for any widening or dredging purposes. Mr. Smith would talk with the City Planner regarding amending the Code of Ordinances but not sure the Comp Plan would be the appropriate place. Mr. Smith had received the same request from Commissioner Johnston.

Commissioner Wardlow asked the City Attorney about the High School Baseball Booster Clubs using the parking lot at Glynn Archer for a fundraiser. Mr. Smith would bring a resolution forward for Commission approval. Assistant City Manager David Fernandez reported in the past parking was allowed with approval by the City Manager's Office.

Commissioner Yaniz asked about non-profit groups from out of town requesting parking at the Eco-discovery Center for Fantasy Fest. Mr. Fernandez stated there is a concern about tour bus parking on the west side of Whitehead and they preferred the Trumbo Road site.

Mr. Yaniz asked Mr. Fernandez about the status of the project matrix. Mr. Fernandez did not know when that would become available.

Mr. Fernandez introduced Dean Walters for the FDOT Quarterly Report on the North Roosevelt

Boulevard project.

Commissioner Lopez asked about the Truman Waterfront multi-use field. He asked Mr. Cintron

to speak on behalf of the Truman Waterfront Advisory Board. Mr. Cintron asked that the field be

improved as soon as possible. He also asked that more information regarding the waterfront project be

made available on the City's website. Richard Tallmadge, Vice-chair of the Truman Waterfront

Advisory Board also addressed the Commission regarding the project.

Commissioner Wardlow asked about the progress at the PAL Gym. Mr. Wardlow also asked

about reusing the A/C units from the fire station to the PAL Gym. Mr. Fernandez was not sure the

electrical would support the A/C units.

Commissioner Yaniz supported Commissioner Lopez regarding the field and it needed attention.

Commissioner Johnston asked who schedules the use of the field and Mr. Fernandez would get

that information for her. He stated without an irrigation system the field could not be maintained.
