A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE PURCHASE OF SIX HACH FLO-DAR METERS FROM THE AVANTI COMPANY IN AN AMOUNT NOT TO EXCEED \$89,081.97 ON A SOLE SOURCE BASIS PURSUANT TO SECTION 2-797(1) FOR BRAND NAME ITEMS IN ACCORDANCE WITH 2-844 OF THE CODE OF ORDINANCES FOR THE NAVY WASTEWATER FLOW CONNECTION POINTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Key West receives Navy Wastewater flow from several navy properties, and meters at several locations are reaching the end of their useful life after more than 10 years; and

WHEREAS, the City has used Hach meters for more than a decade, there is a dedicated service representative in the Florida Keys, and Hach equipment reliably works with current software used by the City; and

WHEREAS, Key West Code of Ordinances section 2-797(1) permits the purchase of goods and services without competition on a sole source basis under certain specified conditions; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION
OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the purchase of six (6) Hach Flo-Dar meters from the Avanti Company for the purpose of metering wastewater flow from the Navy connection points is hereby approved in the amount of \$89,081.97 is hereby approved, pursuant to Section 2-797(1), in accordance with Section 2-844, of the Code of Ordinances.

Section 2: That pursuant to Section 4.9 of the City's contract with the Navy, flow meters are 100% allocable to the Navy, and will be passed through on the next wastewater billing cycle after installation is complete.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
