

RESOLUTION NO. 21-093

A RESOLUTION OF THE CAROLINE STREET CORRIDOR AND BAHAMA VILLAGE COMMUNITY REDEVELOPMENT AGENCY (CRA), APPROVING A TWO YEAR RENEWAL TO THE "MASTER AGREEMENT" BETWEEN THE CRA AND SEA TECH OF THE FLORIDA KEYS, INC. FOR CONSTRUCTION SERVICES - KEY WEST HISTORIC SEAPORT; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution 18-193, the CRA awarded a contract to Sea Tech of the Florida Keys, Inc. for construction services at the Key West Historic Seaport; and

WHEREAS, the Master Agreement was for an initial period of three years, with an option included in Article 4 for additional two-year terms at the discretion of the CRA, and City staff recommends exercising the two-year renewal option; and

NOW, THEREFORE, BE IT RESOLVED BY THE CAROLINE STREET CORRIDOR AND BAHAMA VILLAGE COMMUNITY REDEVELOPMENT AGENCY, AS FOLLOWS:

Section 1: That a two-year renewal of the "Master Agreement" between the CRA and Sea-Tech of the Florida Keys, Inc. for Construction Services for the Key West Historic Seaport is hereby approved.

Section 2: That the City Manager is authorized to execute any necessary documents that are consistent with the approval granted herein, upon the advice and consent of the City Attorney.

Section 3: Specific task orders issued pursuant to the contracts shall comply with the City's procurement guidelines.

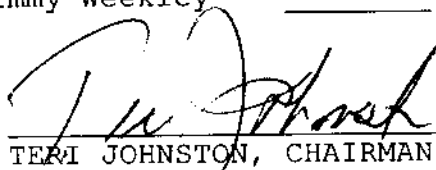
Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Agency.

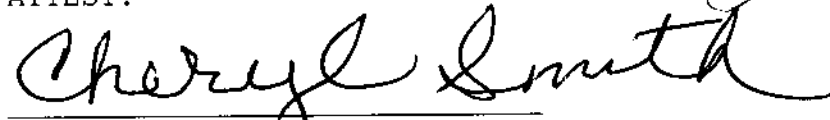

SUBJECT: Construction Services Contract Extension

ACTION STATEMENT

Resolution approving a two-year contract extension for Sea Tech of the Florida Keys, Inc. (Sea Tech) to their Construction Services Contract - Key West Historic Seaport.

BACKGROUND

ITB #18-024 Construction Services was advertised for an indefinite quantities contract for needed maintenance and repairs for buildings located at the Key West Historic Seaport. Sea Tech was one of two contractors awarded a contract through Resolution #18-193.

PURPOSE & JUSTIFICATION

The Seaport has used the Construction Services contract to complete many upland projects with sea Tech including remodeling of both Seaport bathhouses, installation of an ADA accessible restroom at Schooner Wharf, installation of new countertops at the Ferry Terminal restrooms along with replacement of two sets of double entrance doors. Staff has found this contract to be a useful tool in getting these smaller projects and repairs completed.

Sea Tech of the Florida Keys, Inc. has requested to renew their contract for an additional two-year term in accordance with Article 4 of their Master Agreement executed on July 2, 2018.

FINANCIAL IMPACT

The Seaport has budgeted for maintenance and repair projects in different accounts and will specify the account the funds are to be drawn from with the issuance of each task order.

RECOMMENDATION

Staff recommends approving a two-year contract extension for Sea Tech of the Florida Keys, Inc. to their Construction Services Contract - Key West Historic Seaport.
