"FORMAL COMPLAINT" AGAINST OFFICER
"BRIAN LEAHY" #2965 FOR THE FOLLOWING
REASONS:

1) AFTER MY ARREST FOR CASE #CF-87-88-89-AK
ON FEBRUARY 26, 2023 AT 10:12:44 SUNDAY.
SUPERVISOR ON DUTY: FRED "CARTER" SEM'S
#2301; WHILE BEING PROCESSED INTO THE
MONROE COUNTY DETENTION CENTER ON
STOCK ISLAND OFFICER "BRIAN LEAHY" #2965
"ILLEGALLY" AND WITHOUT MY CONSENT TOOK
INTO HIS POSSESSION "2" ECF BAR VAP PINS
FROM MY PERSON AND; AND CEASED THEM IN A
EVIDENCE BAG.

2) HE "ILLEGALLY" CEASED THESE "2" VAP PINS
AGAINST BOOKING OFFICER'S OBJECTIONS
AS WELL, STATING THAT HE WAS JUST GOING TO
DEPOSE OF, DISCARD THROW AWAY FOR HIM.
