A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING TASK ORDER NO. 14 TO ATKINS NORTH AMERICA, INC. FOR CONSTRUCTION MONITORING AND PERMIT COMPLIANCE SERVICES OF BEACH RENOURISHMENT AT SMATHERS BEACH AS REQUIRED BY FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION (FDEP) AND UNITED STATES ARMY CORPS OF ENGINEERS (USACE) IN AN AMOUNT NOT TO EXCEED \$182,327.75; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS, UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 14-359, the City Commission approved a three-year contract with Atkins North America, Inc. for Environmental Engineering Services, and in Resolution 17-299 the contract was renewed for an additional two years; and

WHEREAS, Smathers Beach has undergone significant displacement of sand since the last renourishment in 2013, and the City intends to place approximately 20,000 tons of sand on the beach in accordance with the design and permits procured by Atkins, and approved by FDEP and USACE; and

WHEREAS, the State and Federal permits require construction monitoring and permit compliance services, and staff has determined that these would be most effectively provided by Atkins; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That Task Order No. 14 is hereby approved for Atkins North America, Inc. to provide Construction Monitoring and Permit Compliance Services for Beach Renourishment at Smathers Beach, as required by FDEP AND USACE, in an amount not to exceed \$182,327.75.

Section 2: This project is funded from account No. 103-1900-519-4600/Project FT19001801).

Section 3: That the City Manager is authorized to execute necessary documents, upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
