Dear Ms. Barton:

A review of Code Enforcement case number 10-673 for 1922 Patterson Avenue indicates that on September 29, 2010, the Code Enforcement Special Magistrate imposed an order where you were a Respondent for a City of Key West Code Violation matter. Pursuant to this Order, an Administrative Cost of \$250.00 was imposed. Also imposed was a fine of \$100.00 per day if not in compliance by October 19, 2010. You were also ordered to pay the sewer/solid waste account in full. As of today the total amount due the City of Key West is \$3,250.00 for the fines and fees and \$2,7560.70 for the sewer/solid waste account. It is imperative that you come into compliance to stop the fines from accruing.

If compliance is not achieved and payment is not received by December 17, 2010, this matter will be referred to the Code Enforcement Special Magistrate for a public hearing. An Order will be requested to collect the amount due, and may result in a lien on your property or to pursue the matter as a Court Judgment for enforcement purposes. Florida Statutes Chapter 162 and City of Key West Code of Ordinances Article VI authorize code enforcement proceedings.
