TO CONDUCT THEIR ANNUAL TASTE OF KEY WEST AT THE TRUMAN WATERFRONT EAST OUAY WALL ON MONDAY, APRIL 13, 2015, FROM 6:00 P.M. TO 9:00 P.M; (SET UP STARTING AT 8:00 A.M.); PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER: **AUTHORIZING** THE SALE AND CONSUMPTION ALCOHOLIC BEVERAGES WITHIN AN ENCLOSED AREA; GRANTING AN EXEMPTION FROM THE NOISE CONTROL ORDINANCE PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCE FROM 5:00 P.M. TO 11:00 P.M; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, A.H. of Monroe County, Inc. wishes to conduct their Annual "Taste of Key West" at Truman Waterfront along the east quay wall between the hours of 6:00 p.m. to 9:00 p.m. on Monday, April 14, 2014; and

WHEREAS, this event shall take place on the grounds of the Truman Waterfront between the hours of 6:00 p.m. to 9:00 p.m. on April 14, 2014; and

WHEREAS, the sponsors anticipates that amplified music will be played during the event;

NOW THEREFORE, BE IT RESOLVED, by the City Commission of the City of Key West, Florida;

SECTION 1. That A.H. of Monroe County, Inc. is hereby granted permission to conduct their "Taste of Key West" on the date and during the hours stated above; PROVIDED all trash is adequately collected and contained; guarantee indemnifying the City is executed;

and provided the organizations meet the terms and conditions set forth by the City

Manager.

SECTION 2. That pursuant to Section 18-86 of the Key West Code of Ordinances, A.H. of Monroe County, Inc. is hereby granted permission allowing the sale and consumption of alcoholic beverages within an enclosed area.

SECTION 3. That A. H. of Monroe County, Inc. is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place at the place and time herein described.

SECTION 4. That any use of the Truman Waterfront properties should be coordinated and approved through the Local Redevelopment Agency Office.

SECTION 6. A.H. of Monroe County, Inc. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used that that they will be placed side by side.

SECTION 7. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
