A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AWARDED THE BID OF CHARLEY TOPPINO & SONS, INC. RECEIVED IN RESPONSE TO INVITATION TO BID (ITB) #22-002 FOR C.B. HARVEY REST BEACH SHELTERS (PROJECT NUMBER IS19001902) IN A TOTAL AMOUNT NOT TO EXCEED \$91,197.50; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS AND ADJUSTMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT IN SUBSTANTIAL CONFORMANCE WITH THE BID PROPOSAL, UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City issued ITB 22-002 for C.B. Harvey Rest Beach Shelters Project, and four bids were opened on November 10, 2021; and

WHEREAS, City staff finds the lowest bid, submitted by Charley Toppino & Sons, Inc., to be responsive and responsible, and recommends award of the bid to Charley Toppino & Sons, Inc.

WHEREAS, a portion of this project will be paid for with Tourist Development Funds, which were originally allocated and accepted in the 2019 TDC Bricks and Mortar Capital Projects funding cycle in Resolution 19-101, and renewed to ensure funding remains available.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION
OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the bid of Charley Toppino & Sons, Inc. is hereby awarded in response to ITB 22-002 for C.B. Harvey Rest Beach Shelters, in an amount not to exceed \$91,197.50.

Section 2: That the project will be funded in part (\$35,000.00) through TDC Grant revenue account No. 101-0000-337-7001 (Project IS19001902) and the project is budgeted and will be paid from account 101-1900-519-6300 (Rest Beach Enhan/Infrastructure) Project IS19001902. Any necessary budget adjustments or amendments are hereby authorized.

Section 3: That the City Manager is hereby authorized to execute a contract in substantial conformance with the bid documents upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
