A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A TASK ORDER UNDER THE CITY'S **GENERAL** UTILITIES AND INFRASTRUCTURE CONTRACT WITH CHARLEY TOPPINO & SONS, INC. IN A TOTAL AMOUNT NOT TO EXCEED \$104,664.67 FOR CONCRETE AND LEAK REPAIRS AT THE RICHARD ENVIRONMENTAL PROTECTION HEYMAN FACILITY (RAHEPF) CONTACT BASINS; ANY AUTHORIZING NECESSARY BUDGET ADJUSTMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE DOCUMENTS UPON CONSENT OF THE ATTORNEY; PROVIDING FOR EFFECTIVE DATE

WHEREAS, in Resolution No. 21-125, the City Commission approved a three-year General Utilities and Infrastructure Services contract with Charley Toppino & Sons, Inc.; and

WHEREAS, City staff recommends approval of a Task Order for concrete and leak repairs at the RAHEPF contact basins to improve safety, efficiency and appearance; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the attached Task Order under the City's General Utilities and Infrastructure Contract with Charley Toppino & Sons, Inc. in a total amount not to exceed \$104,664.67, for

concrete and leak repairs at the RAHEPF contact basins, is hereby approved.

Section 2: That funding for the task order is budgeted in Sewer Repairs and Maintenance, account 401-3504-535-4600. Any necessary budget transfers or adjustments are hereby authorized.

Section 3: That the City Manager is authorized to execute any necessary documents for this project, upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
