A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AWARDING THE BID OF DOUGLAS N. HIGGINS, INC., FOR CONSTRUCTION OF EAST FRONT STREET FLOOD MITIGATION PROJECT NO. ST-1201 IN THE AMOUNT OF \$2,964,012.50; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on July 17, 2014, two responsive bids were opened for the Construction of East Front Street Flood Mitigation, Project No. ST-1201, with Douglas N. Higgins, Inc. submitting the lowest bid; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the bid of Douglas N. Higgins, Inc. in the amount of \$2,964,012.50 is hereby awarded, and the City Manager is authorized to enter into a contract in conformity with the bid documents upon the advice and consent of the City Attorney.

Section 2: That FEMA Phase II grant funding (approved in Resolution No. 14-065) provides 75% of construction costs up to \$2,454,440.00, with a 25% city match, and 100% funding for administration costs, up to \$40,408.00. Funds will be deposited into Stormwater Utility revenue account 402-331-550. Construction funds for East Front Street Flood Mitigation, Project No. ST-1201 are budgeted in expense account 402-3802-538-65.
