WHEREAS, the Department desires to participate in all eligible items for this project as outlined in Attachment
"A" for a total Department Share of \$4,969,417.00

NOW, THEREFORE THIS INDENTURE WITNESSETH: that for and in consideration of the mutual benefits to flow
from each to the other, the parties hereto agree that the above described Joint Participation Agreement is to be amended
and supplemented as follows:

- provide SFY18 FTA Section 5311-Rural Capital Grant Award to the City of Key West Transit for the purchase of Bus
Fleet replacements and needed equipment.

- Grant Participation is 80/20 - FTA/Local (Local Funds will use Toll Revenue Credits)

Proposed Project Description

The Section 5311 Capital Non-Urbanized Area funding allows the City of Key West the ability to purchase necessary equipment and / or support vehicles to continue operations of a fixed route public transit system that not only serves the citizens and visitors of Key West, but also up to MM 53.5, City of Marathon.

Key West Transit is currently operating at the New Transit Facility located at 5701 W College Road, Key West, FL. The new facility houses all transit administration, operations, and maintenance activities.

Key West Transit staff has had discussions as to the additional items needed for the New Transit. The items are as follows:

- Purchase up to 5 Gillig BRT Clean Diesel Buses
- Camera system for buses
- Hard drive for camera system
- Wheelchair ramps
- Fareboxes
- Annunciators
- GPS/Real Time Passenger Information System (RTPIS)
- IT Equipment

Other items for future planning purchases are as follows but not in the order presented:

- Smaller support vehicles
- Off board fare system
- Transit connect equipment hauler

Funding assistance and the purchase of necessary equipment will provide the transit employees' to perform their job duties in an efficient and effective manner.
