A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE PURSUANT TO SECTION 2-797(3) AND 2-797(4)(B) OF THE CODE OF ORDINANCES OF A SPECIALTY FORD POLICE TRANSIT VAN FROM THE SIRCHIE ACQUISITION COMPANY, LLC -- VEHICLE DIVISION UNDER GSA CONTRACT #GS07F007DA IN AN AMOUNT NOT TO EXCEED \$51,228.73 FOR THE KEY WEST POLICE DEPARTMENT; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, section 2-797(3) of the Code of Ordinances authorizes purchases pursuant to State government contracts; and

WHEREAS, the base model Ford van which Sirchie will convert to a Police Transit Van is not included under Government contract pricing, but is included as an "Open Market Item" within the Sirchie price quote, at the cost of \$32,093.00. Certain accessories, available only pursuant to open market pricing in the amount of \$4,375.00, and shipping in the amount of \$2,040.00, are also included in the Sirchie price quote;

WHEREAS, City staff has determined that open market pricing for similar vehicles is comparable to the price quoted by Sirchie, and that the purchase of the van, plus shipping and certain accessories, totaling \$38,508.00, is in the best interests of the City pursuant to section 2-797(4)(b) of the Code of Ordinances; and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of a Specialty Ford Police Transit Van with equipment and accessories, in an amount not to exceed \$51,228.73, from the Sirchie Acquisition Company, LLC -- Vehicle Division, is hereby approved.

Section 2: That \$12,720.73 of the purchase price is authorized pursuant Section 2-797(3) of the Code of ordinances, under GSA Contract No. GS-07F-007DA, and \$38,508.00 of the purchase price is authorized pursuant to section 2-797(4)(b), best interests of the City.

Section 2: That funds for this purchase are budgeted in police account 101-2101-521-6400 for FY 15/16.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
