

RESOLUTION NO.26-_____

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA APPROVING CHANGE ORDER NO. 1 TO STANTEC CONSULTING SERVICES, INC. IN THE AMOUNT OF \$62,807.87, AS ATTACHED HERETO AND MADE A PART HEREOF, FOR KEY WEST WATER QUALITY MONITORING; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS AND BUDGET AMENDMENTS/TRANSFERS, UPON THE ADVICE AND CONSENT OF THE CITY ATTORNEY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, via Resolution 25-299, the City Commission authorized the City Manager to negotiate and execute a contract with the top-ranked firm Stantec Consulting Services, Inc. for Water Quality Professional Services; and

WHEREAS, via Resolution 26-023, the City Commission authorized the Scope of those Services, which included Task Zero: Resume Key West Harbor Monitoring, and

WHEREAS, the City received a quote for Task Zero from Stantec, which necessitates a change order of \$62,807.87; and

WHEREAS, funds will be transferred from Adaptation and Sustainability reserve account 108-3801-538-9803 to Account 108 3702 537 3100 (Adaptation and Sustainability);

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Commission hereby approves Change Order No. 1 to the City's contract with Stantec Consulting

Services, Inc. in the amount of \$62,807.87 attached hereto and made a part hereof, for Key West Water Quality Monitoring to be paid from the FY2025 Water Quality Monitoring allocation held in Reserve Account 108-3801-538-9803.

Section 2: That the City Manager is hereby authorized to execute any necessary related documents and budget transfers/amendments, upon the advice and consent of the City Attorney.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
