A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE ROTARY CLUB OF KEY WEST, FLORIDA, INC. TO CONDUCT A KEYS STOCK 2014 MUSICAL CONCERT AT THE TRUMAN WATERFRONT SOUTHWEST FIELD ON SATURDAY, MAY 3, 2014, FROM 9:00 A.M. TO 5:00 P.M (SET UP) 5:00 P.M. TO 10:00 P.M.; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN AN ENCLOSED AREA; GRANTING AN EXEMPTION FROM THE NOISE CONTROL ORDINANCE PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES DURING THE EVENT; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Key West Rotary Club of Key West, Florida, Inc. wishes to conduct a Musical Concert at the Truman Waterfront Southwest Fields between the hours of 9:00 a.m. to 11:00 p.m. on Saturday, May 3, 2014; and

WHEREAS, this event shall take place on the grounds of the Truman Waterfront between the hours of 9:00 a.m. to 11:00 p.m. on May 3, 2014; and

WHEREAS, the sponsor anticipates that amplified music will be played during the event;

NOW, THEREFORE, BE IT RESOLVED, by the City Commission of the City of Key West, Florida;

SECTION 1. That the Key West Rotary Club of Key West, Florida, Inc. is hereby granted permission to conduct a Musical Concert on the date and during the hours stated above; PROVIDED all trash is adequately collected and contained; guarantee indemnifying the City is executed; and provided the organizations meet the terms and conditions set forth by the City

Manager.

SECTION 2. That pursuant to Section 18-86 of the Key West Code of Ordinances, The Key West Rotary Club, Florida, Inc. is hereby granted permission allowing the sale and consumption of alcoholic beverages within an enclosed area.

SECTION 3. That the Key West Rotary Club of Key West, Florida, Inc. is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place at the place and time herein described.

SECTION 4. That any use of the Truman Waterfront properties should be coordinated and approved through the Local Redevelopment Agency Office.

SECTION 5. That the Key West Rotary Club of Key West, Florida, Inc. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

SECTION 6. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
