**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE WILLIAM WEECH AMERICAN LEGION AUXILIARY POST 168 TO CONDUCT A FUNDRAISING BATTLE OF THE DJ'S ON THE 800 BLOCK OF EMMA STREET BETWEEN PETRONIA AND OLIVIA STREETS ON FRIDAY, NOVEMBER 25, 2011 AND ON SATURDAY, NOVEMBER 26, 2011 STARTING AT 12:00 NOON TO 6:00 P.M.; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN AN ENCLOSED AREA; GRANTING AN EXEMPTION FROM THE NOISE CONTROL ORDINANCE PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCE DURING THE EVENT; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS,** The William Weech American Legion Auxiliary Post 168 wishes to conduct a Fundraising Battle of the DJ's on Friday, November 25, 2011 and Saturday, November 26, 2011 from 12:00 noon to 6:00 p.m. each day.

**WHEREAS,** this event shall take place on the 800 block of Emma Street between Petronia and Olivia Streets; and

**WHEREAS,** the sponsors anticipates that amplified music will be played during the event;

**NOW THEREFORE, BE IT RESOLVED,** by the City Commission of the City of Key West, Florida;

**SECTION 1.** That the William Weech American Legion Auxiliary Post 168 is hereby granted permission to conduct their "Battle of the Bar's" on the date and during the hours stated above; **PROVIDED** all trash is adequately collected and contained;

guarantee indemnifying the City is executed; and provided the organizations meet the terms and conditions set forth by the City Manager.

**SECTION 2.** That pursuant to Section 18-86 of the Key West Code of Ordinances, the William Weech American Legion Auxiliary Post 168 is hereby granted permission allowing the sale and consumption of alcoholic beverages within an enclosed area.

**SECTION 3.** That the William Weech American Legion Auxiliary Post 168 is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place at the place and time herein described.

**SECTION 4.** That any use of the Truman Waterfront properties should be coordinated and approved through the Local Redevelopment Agency Office.

**SECTION 5.** That the William Weech American Legion Auxiliary Post 168 will adhere to the recycling plan of the City of Key West, that one (1) container for every one (1) trash barrels will be used and that they will be placed side by side.

**SECTION 6.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
