A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, ACCEPTING/DENYING THE ATTACHED CONTRACT AMENDMENT REQUEST FROM WASTE MANAGEMENT OF FLORIDA, INC. (WMI) FOR AMENDMENTS TO SOLID WASTE AND RECYLING COLLECTION SERVICE RATES FOR RESIDENTIAL AND COMMERCIAL UNITS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on May 6, 2014, the City Commission awarded the bid of Waste Management Inc. (WMI) of Florida in response to ITB 14-009, and on June 25th, 2014 a Contract was executed for the collection, transfer and disposal of solid waste and recyclable materials and transfer station operation; and

WHEREAS, in Resolution No. 14-254, the City Commission approved a First Amendment to Contract, and in Resolution No. 16-048 the City Commission approved a Second Amendment to Contract; and

WHEREAS, Waste Management, Inc. has proposed certain changes to the contract, including amending the current cost index from CPI-U to CPI-WST (water, sewer, trash), along with other adjustments to commercial and residential waste and recycling fees not contemplated in the current agreement; and

WHEREAS, the City's contract with Waste Management will be eligible for a renewal for an additional four years, pursuant to the current contract, effective January 1, 2022, and the City Commission finds it acceptable/unacceptable to adjust the contract prior to the renewal period; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Commission hereby accepts/denies the attached contract amendment request from Waste Management of Florida, Inc. for amendments to residential and commercial solid waste and recycling collection service rates.

Section 2: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
