I am in support of the new HARC guidelines. I live where the proposed major new construction at the current Sea Shell Hostel in the Casa Marina District has been approved. > My wife and I have owned a house in the Old Town historic district for 16 years.
> We strongly urge HARC to make sure that any revisions to its HP
> guidelines provide the maximum protection for all structures in Old
> Town. Moreover, we urge the maximum protection of the streetscapes in

> their totality, to preserve and protect both the historic and
> architectural charm of Old Town. New structures on vacant lots should
> be compatible in scale and texture with their visible surroundings,
> while allowing for sufficient differentiation to demark the new from the old, in keeping with prevailing historic preservation theory.

> My wife and I have lived in historic districts, renovating homes in
> them, since 1972. We have in fact helped establish three of those
> historic districts, always trying to obtain maximum protections for contributing structures.

>
> We have had the highest regard for HARC's stewardship of the HD, and
> for the professionalism and evenhandedness of its staff. In 2005,
> Wilma flooded our home, requiring a substantial rebuilding. We
> worked closely with HARC, getting helpful advice on restoration. We
> were glad that their guidelines were strict and comprehensive, because
> we knew that our surroundings would be maintained to the same
> standards of authenticity. HARC was in no small measure helpful in our getting a "gold star" from OIRF for our renovation.

> We recognize that HD guidelines need to take periodic account of the
> perils of nature and to some extent the requirements of mortgages and insurance.
> However, these variables should not become an excuse for laxity in
> standards or the maintenance of the authenticity of the HD.

> Ket West is a unique historical and architectural area. The tourist
> industry, the real estate industry, and many other local jobs depend
> directly on the integrity of the HD. It is the chief reason people want to live here.

> We have noticed recently a few new - commercial - structures that
> seem glaringly incompatible with their HD surroundings, even under a
> liberal interpretation of HARC guidelines. We hope that HARC's rigor
> and evenhandedness are not slipping. We urge the strictest possible
> guidelines to protect Old Town.

I cannot attend the February 23rd meeting, but I would like to have the following comments read into the record:

Dear HARC Commissioners:

I am in receipt of a flyer from KOTO appealing for my support of changes to HARC guidelines governing new construction in Old Town. I was deeply disturbed by what I saw in the flyer, and it has moved me to offer some comments.

While I do support any efforts to clarify confusing or conflicting language in the guidelines, I emphatically reject any attempts to arrest the development of non-historic architecture. As a proud homeowner of a 108-year-old house in Old Town, I wholeheartedly endorse the concept of preservation to maintain the character and historic fabric of our Old Town homes. However, as much as I love my house, and for as much time and effort as I have invested in restoring the old wooden porch, Dade County Pine siding, and glazed wooden windows, I would be appalled to have new construction built in my neighborhood that tried to mimic what is truly historic. Of course mass and scaling should fit the neighborhood, but “Disney-fying” Old Town is a disservice to the spirit of the national guidelines and an abomination to the character of Key West!

I purchased an old house because it is my taste; I am admittedly not a fan of more modern architecture. However, that does not mean it shouldn't exist, and that there shouldn't be a place for it in Key West. The new Seven Fish building on Truman Avenue, which KOTO so reviles in their propaganda flyer, makes for an interesting contrast to the historic buildings in its neighborhood, rather than being a slavish, boring, and unimaginative copy.

I am also concerned the KOTO movement is not so much a noble cause, as a perversion of preservation to suit its own NIMBY agenda. It is noteworthy to remember when considering the hoopla around these new guidelines that the leaders of the KOTO movement began their crusade after the new owners of 616 Eaton Street were granted approval to build a family compound on the site which had been marketed in 2013 as a “RENOVATOR’S DREAM. PERFECT PROPERTY FOR A FAMILY COMPOUND OR CORPORATE RETREAT” by the previous owners. If one is to believe what is posted on the Monroe County Appraiser’s website, the bitter irony is that the previous owners of 616 Eaton also happen to own 416 Elizabeth Street. Apparently they weren’t too concerned about the historic integrity of 616 Eaton when they bought it in 2012, lopped off 2500 square feet to add to their own yard on Elizabeth Street, allowed it to further fall into disrepair, and then flipped it for \$150,000 more than they paid for it. The moral outrage and the public hand-wringing only began when their slick marketing technique actually brought the plan home to roost – literally – in their backyard. Rather than live with the consequences of the deal they advertised, they launched a smear campaign and vilified the HARC commission in the press, through social media, and now backhandedly through this mass-mailing in order to raise public ire and deflect blame away from a situation of their own creation.

It is important to remember that the HARC commissioners are volunteers, some of whom are professional architects, and they are doing commendable yet thankless work for the City. Though we may not always agree with their decisions, the Commission, Enid Torregrossa, and her staff deserve our praise and admiration for taking on the impossible task of balancing history, practicality, and the wildly divergent personalities in the City of Key West. Regardless of where one stands with respect to these new guidelines, let us also remember to have respect for these dedicated public servants, and dispense with the self-serving mudslinging from a well-funded vocal minority.
