A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AUTHORIZING THE PURCHASE OF FOUR (4) 2024 HARLEY DAVIDSON POLICE ROAD KING MOTORCYCLES AND ASSOCIATED EQUIPMENT AT A TOTAL AMOUNT NOT TO EXCEED \$89,080.16 FROM ALLIGATOR ALLEY HARLEY DAVIDSON THROUGH THE HILLSBOROUGH COUNTY SHERIFF 2024-2025 ASSORTED VEHICLE PROCUREMENT CONTRACT, PURSUANT TO SECTION 2-797(3)-GOVERNMENTAL PURCHASING CONTRACT OF THE CITY'S CODE OF ORDINANCES FOR USE BY THE KEY WEST POLICE DEPARTMENT; AUTHORIZING THE TRADE-IN OF UP TO FOUR (4) 2022 MOTORCYCLES CURRENTLY IN USE BY THE KEY WEST POLICE DEPARTMENT, UPON RECEIPT AND ACCEPTANCE OF A FAIR AND EQUITABLE OFFER; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY RELATED DOCUMENTS AND/OR BUDGET TRANSFERS/ADJUSTMENTS, UPON CONSENT OF THE CITY ATTORNEY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Key West Police Department (hereinafter "the Department") finds that Harley Davidson Police Road King motorcycles best meet the Department's needs based on performance, rider training, maintenance and service history; and

WHEREAS, in May of 2025 the Department was informed that Harley Davidson intends to phase out the Police Road King model and transition to the Police Road Glide model. At that time, Alligator Alley Harley Davidson provided our Traffic Unit with a Road Glide model to test and evaluate. After approximately three (3) months of extensive testing and evaluation it was determined the Road Glide model was not preferred by our Traffic Unit; and

WHEREAS, in August of 2025 the Department learned Alligator Alley still had four (4) remaining 2025 Police Road King models available for purchase and requested the City Manager's approval

to provide Alligator Alley Harley Davidson with a letter of intent to purchase the available four (4) 2025 Police Road King motorcycles available, pending the Commission's approval of the City's FY 2025/2026 budget; and

WHEREAS, with the Commission's approval of the FY 2025/2026 budget, funds are now budgeted and available in Account #101-2101-521-6400 - *Machinery and Equipment*. for the purchase of the four (4) available 2025 Harley Davidson Police Road King motorcycles from Alligator Alley Harley Davidson; and

WHEREAS, Alligator Alley Harley Davidson will provide a trade-in offer for up to four (4) 2022 motorcycles currently in use by the Key West Police Department and staff is requesting Commission approval to trade-in the four (4) 2022 motorcycles, only upon receipt and acceptance of a fair and equitable offer, as determined by City staff. If the offer is not determined fair and equitable and in the best interest of the City, the motorcycles will be turned over to the City Garage to be auctioned. The price reflected in the attached quote does not include any value which will be gained from the trade-in or auction; and

WHEREAS, Harley Davidson Police Road King motorcycles have been used by the Department for over twenty (20) years and continue to meet/exceed the Traffic Unit's requirements for performance and dependability. The duties and functions of the Traffic Unit include, but are not limited to, parade escorts, dignitary escorts,

special event participation and daily traffic enforcement operations. These specific motorcycles are critical to meeting the expanding mission requirements of the Traffic Unit and the Key West Police Department;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the Commission hereby authorizes the purchase of four (4) Harley Davidson Police Road King motorcycles and associated equipment through the Hillsborough County Sheriff 2024-2025 Assorted Vehicle Procurement Contract, pursuant to Section 2-797(3) of the City's Code of Ordinances in a total amount not to exceed \$89,080.16 to be paid from Account #101-2101-521-6400 - *Machinery and Equipment*.

Section 2: That, pursuant to Section 2-771(c) of the City's Code of Ordinances, the Commission hereby authorizes the disposal (trade-in) of up to four (4) City-owned 2022 Harley Davidson Police Road King motorcycles upon receipt of a fair and equitable trade-in offer from Alligator Alley Harley Davidson on the day of the trade-in. City staff is authorized to negotiate, receive and accept (or refuse) a trade offer upon fair and equitable terms on the day of trade-in. If the trade-in offer presented the date of the trade-in is not found to be fair and equitable and in the best interest of the City, the four (4) 2022 Harley Davidson Police

Road King motorcycles will be turned over to the City Garage for auction.

Section 3: That the City Manager, or designee, is authorized to execute any necessary related documents and budget transfers/adjustments, upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
