A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING PURSUANT TO SECTION 2-797(3) THE PURCHASE OF 40 HP DESKTOP COMPUTERS FROM MRA INTERNATIONAL IN AN AMOUNT NOT TO EXCEED \$30,400.00 THROUGH THE STATE OF FLORIDA CONTRACT - MISCELLANEOUS IT EQUIPMENT (WSCA) 250-WSCA-10-ACS (ALTERNATE CONTRACT SOURCE); AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, section 2-797(3) of the Code of Ordinances authorizes purchases pursuant to government contract; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of a 40 Desktop Computers (25 HP Computers for use by City - \$19,000, 15 for use by KWPD - \$11,400), in a total amount not to exceed \$30,400.00, from MRA International is hereby approved, through State of Florida Contract - Miscellaneous IT Equipment (WSCA) 250-WSCA-10-ACS, pursuant to Section 2-797(3) of the Code of Ordinances.

Section 2: That adequate funds for this purchase are budgeted in FY 2019. 15 Computers (\$11,400) will be purchased for Police Department from account 001-1201-521-5200, 25 computers (\$19,000) will be purchased for Information Technology Department from Account 001-1303-513-5200.

Section 3: That the City Manager is authorized to execute any necessary documents upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
