January	National Endowment for the Arts (NEA) -- Our Town	Art Committee	Organizations may apply for creative placemaking projects that contribute to the livability of communities and place the arts at their core. (\$25,000 to \$200,000.)
February	NEA Art Works	Art Committee	To support the creation of art that meets the highest standards of excellence, public engagement with diverse and excellent art, lifelong learning in the arts, and the strengthening of communities through the arts. (up to \$100,000)
February	NEA Challenge America Fast Track	Art Committee	To support projects that extend the reach of the arts to underserved populations. (\$10,000)
March	Land and Water Conservation Fund	Recreation/park facilities with water access. Truman Waterfront Park.	Up to \$200,000 in matching funds.
April	Florida Section 319 nonpoint source management grant	Stormwater projects. Canal clean-up.	All projects should include at least a 40% nonfederal match.  Examples of fundable projects include: demonstration and evaluation of Best Management Practices (BMPs), nonpoint pollution reduction in priority watersheds, ground water protection from nonpoint sources, public education programs on nonpoint source management, etc.
