A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE ATTACHED "TASK ORDER 09-24 FOR REHABILITATION OF PUMP STATION 'J'" BETWEEN THE CITY OF KEY WEST AND JACOBS ENGINEERING GROUP, INC. IN AN AMOUNT NOT TO EXCEED \$321,300.00 TO PROVIDE ENGINEERING DESIGN, PERMITTING, BID AND CONSTRUCTION PHASE SERVICES; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS AND ADJUSTMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in resolution No. 23-029, the City Commission approved Staff Ranking of respondents for RFQ 22-006 for General Engineering Services and authorized the City Manager to execute a contract negotiation with the top ranked firms, including Jabcobs Engineering Group, Inc. and

WHEREAS, this task order will include design tasks related to upgrades to add, replace and repair deteriorating equipment for pump station "J" as recommended in the 2015 Pump Station Condition Assessment and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached "Task Order for

Rehabilitation of Sanitary Pump Station "J" between the City of Key West and Jacobs Engineering Group, Inc. is hereby approved in the amount not to exceed \$321,300.00.

Section 2: That this project is budgeted in account 401-3503-535-6500 (Project No. SE35032501) and any related budget transfers or adjustments are hereby authorized.

Section 3: That the City Manager is authorized to execute any necessary documents, upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
