The Complainant, Johnny Nash, came to the CRB office to file this complaint with the traffic tickets and other documents supporting his complaint. On January 26, 2011, Mr. Nash was stopped by Officer David Hall in the area of Amelia & Howe. Mr. Nash was on his bicycle and was issued tickets for:

- a. running a stop sign
- b. driving the wrong way on a one-way road

During his detainment Mr. Nash states that Officer Hall took his identification, a gold watch and a silver pocket knife from him. This property was not returned to him upon his release from the traffic stop. When he went to the police department he was told there was no case report and no property turned in to them.


