On Arrival, I knocked for several minutes. I could see lights coming off an on in the home. I could make out Ginos mother, known to me from numerous contacts as Renata King. Renata finally came to the door and opened it. I requested to speak with Gino. Gino then appeared in the living room. I entered and told him he was under arrest for his warrant.

Gino said no and actively physically resisted my attempts to place him under lawful arrest. Gino actively pulled away from my grasp, attempted to pull away and run. Ofc. Moore and Lt. Vazquez had to help me gain physical control over Gino as he refused to obey lawful commands to place his hands behind his back.

With Lt. Vazquez and Ofc. Moores assistance we assisted Gino to the ground as he continued to pull away from our grasps. Once Gino was placed under arrest I placed him in my patrol vehicle.

Gino did not suffer any visible injury of make any complaints of injury. Gino echibited the odor of Marijuana on his breath and person. DJJ Nancy Alvarez notified.
