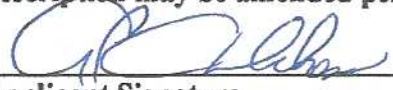

30 - Day Plan

During the first 30 days as the City Manager of the City of Key West, I would concentrate on getting to know the staff and the Business and Civic Leaders of the Community. With respect to the Executive Staff, I would first meet with the staff as a group and then individually. During those meetings, I would spell out my goals and work on gaining the trust of the Executive Team. I would listen to their concerns and frustrations; agree to short term goals on moving the organization forward; building a team environment; and working on improving the overall employee morale. With respect to the Business and Civic Leaders, I would meet with them individually to also discuss their concerns and determine how the city could better meet the needs of the business community.

60 - Day Plan

During the second month as the City Manager of the City of Key West, I would meet individually with the Mayor and City Commissioners to inform them of my observations. I would share with them the discussions that have occurred in obtaining goals and objectives and asking for input on moving forward. The priority here would be on improving the morale and getting the employees to understand the objectives ensuring the employees are engaged. Employees need to understand that they are valued, and they are vital to the organization. Once that is concluded, I would meet with the Union Leaders to share with them the plan and gain their support.

90 Day Plan

In my third month as the City Manager, I would have a general understanding of City Hall and the Community and start developing short term and long-term goals. Full transparency is a priority for my administration. I would have established procedures and a culture of full disclosure. During this time, I would make sure that those procedures are being followed. I would review the City Council meeting process to improve efficiency and engage Department Directors. Letters to Council (LTC's) will be established to keep the Mayor, City Council, Residents and Business owners informed of City events, etc. Short term and long-term goals would begin to be established and the format for the Annual Strategic Planning Session would be discussed.

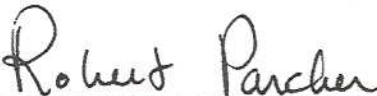

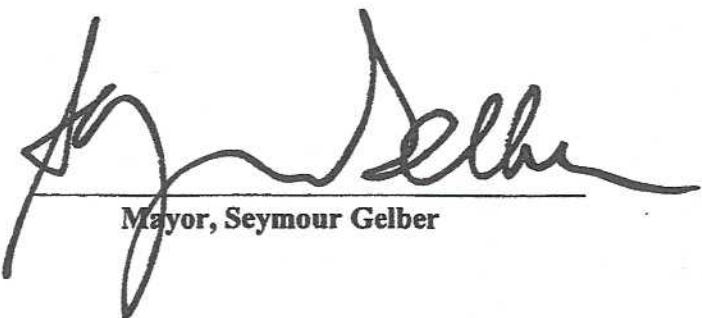

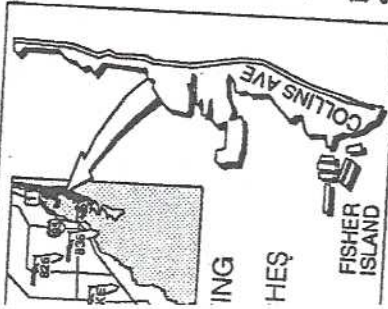

New code enforcer is ready to clean up

There's a new enforcer in town. His name is Albert Childress. And as Miami Beach's new Code Compliance director, he already has his hands full.

"We want to avoid problems before they start," Childress, 41, said. "Educate people so that they are sure of what they can and cannot do."

Childress was named to the slot two weeks ago, making him responsible for handling complaints, enforcing zoning and building codes and inspecting buildings throughout the Beach.

First on his agenda: education. He said he hopes to inform property owners of city ordinances and building codes. Many problems could be evaded if people knew the rules, he said.

He's done this before. Childress worked for Metro-Dade's building and zoning department for 13 years before moving to the Beach. The two jobs, he said, are similar.

Joe Damien, the former code compliance director, said he's leaving the department in good hands.

"He is very knowledgeable of enforcement techniques and pro-

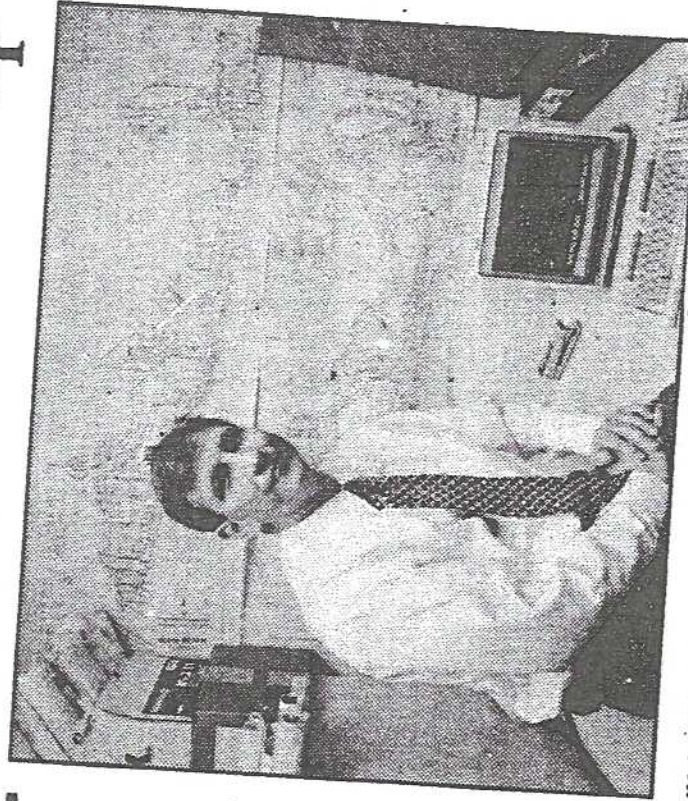
cedures since he worked for Dade so many years," Damien said. "We are focusing on providing him with as much information as possible about the specific area. We want to make him well-informed of different city ordinances, code provisions and policy procedures in Miami Beach."

Childress agrees that the Beach offers new challenges. The city's main problem is illegal fliers, posters and stickers plastered on city property, he said.

He has a plan: free inspectors of other responsibilities so they can dedicate more time to hands-on surveys throughout the Beach.

"We want to stop potential problems before they become full-blown problems," he said.

Childress, a Biscayne Park resi-

dent, graduated from St. Thomas University with a bachelor's degree in criminal justice and public administration and with a master's degree in public administration from Florida International University.
