A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING ROTARY CLUB OF KEY WEST, FLORIDA, INC. TO HOLD THE ROTARY 4TH OF JULY 5K ON FRIDAY, JULY 4, 2025, FROM 7:30 A.M. – 10:00 A.M. (SETUP AT 5:30 A.M.) WITHIN THE STREETS OF KEY WEST; AUTHORIZING THE CLOSURE OF CERTAIN STREETS OR PORTIONS THEREOF FOR SAID RACE FROM 7:30 A.M. TO 10:00 A.M.; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, The Rotary Club of Key West, Florida, Inc. wishes to conduct the "Rotary 4th of July 5K" beginning and ending at the Edward B. Knight Pier during the hours of 7:30 a.m. to 10:00 a.m. (setup at 5:30 a.m.) on Friday, July 4, 2025.

BE IT RESOLVED by the City Commission of the City of Key West, Florida, as follows:

SECTION 1: That in Resolution 19-174, the City Commission directed the City Manager to "develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the local government for the provision of good or services, unless such use is otherwise preempted by law."

SECTION 2: That the vendor/lessee/licensee acknowledges the City's concern about the negative environmental impact of using

disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor therefore commits to refrain from the use of polystyrene/plastic straws, bags, plastic utensils and "To go" packages for food or products sold on any property leased from the City.

SECTION 3: That The Rotary Club of Key West, Florida, Inc. is hereby granted permission to hold the "Rotary 4th of July 5K" starting and ending at the Edward B. Knight Pier on Friday, July 4, 2025, from 7:30 a.m. to 10:00 a.m. (setup at 5:30 a.m.)

SECTION 4: That Rotary Club of Key West, Florida, Inc. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for everyone (1) trash barrels will be used and that they will be placed side by side.

SECTION 5: That Rotary Club of Key West, Florida, Inc. pledges that proceeds will benefit the Rotary Club of Key West Scholarship Fund.

SECTION 6: That The Rotary Club of Key West, Florida, Inc. acknowledges that they are responsible for payment to the Key West Police Department, the Key West Fire Department and Community Services.

SECTION 7: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officers and Clerk of the Commission.
