A RESOLUTION OF THE CITY COMMISSION OF THE OF KEY WEST, FLORIDA APPROVING PURCHASE AND INSTALLATION OF ARTIFICIAL TURF HERNANDEZ FIELD FROM CORPORATION IN THE AMOUNT OF \$987,738.00, THROUGH THE SOURCEWELL CONTRACT, PURSUANT TO SEC. 2-797(3) OF THE CODE OF ORDINANCES OF THE CITY OF KEY WEST, FLORIDA; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY CONTRACTS, BUDGET TRANSFERS OR AMENDMENTS, UPON CONSENT OF THE CITY ATTORNEY'S OFFICE; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Sec 2-797(3) of the Code of Ordinances authorizes purchases pursuant to government contract; and

WHEREAS, Sourcewell is a State of Minnesota local government agency and service cooperative created under the laws of the State of Minnesota (Minnesota Statutes Section 123A.21) that offers cooperative procurement solutions to its members; and

WHEREAS, the City of Key West is a member of Sourcewell, ID No: 58115; and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: The City Commission hereby approves the purchase and installation of an artificial turf field at Pepe Hernandez Field from AstroTurf Corporation in the amount of \$987,738.00

through Sourcewell competitive bid contract, pursuant to Sections 2-797(3) of the Code of Ordinances.

Section 2: The purchase and installation of an artificial turf field is funded under the Infrastructure Surtax/Parks and Recreation/Infrastructure Account No. 101-7201-572-63.

Section 3: The City Manager is authorized to execute any necessary documents and budget transfers or amendments, associated with this purchase, upon consent of the City Attorney's office.

Section 4: This Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
