A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA APPROVING THE PURCHASE AND INSTALLATION OF ARTIFICIAL TURF AT PEPE HERNANDEZ FIELD FROM ASTROTURF CORPORATION IN THE AMOUNT OF \$987,738.00, THROUGH THE SOURCEWELL CONTRACT, PURSUANT TO SEC. 2-797(3) OF THE CODE OF ORDINANCES OF THE CITY OF KEY WEST, FLORIDA; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY CONTRACTS, BUDGET TRANSFERS OR AMENDMENTS, UPON CONSENT OF THE CITY ATTORNEY'S OFFICE; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Sec 2-797(3) of the Code of Ordinances authorizes purchases pursuant to government contract; and

WHEREAS, Sourcewell is a State of Minnesota local government agency and service cooperative created under the laws of the State of Minnesota (Minnesota Statutes Section 123A.21) that offers cooperative procurement solutions to its members; and

WHEREAS, the City of Key West is a member of Sourcewell, ID No: 58115; and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: The City Commission hereby approves the purchase and installation of an artificial turf field at Pepe Hernandez Field from AstroTurf Corporation in the amount of \$987,738.00

through Sourcewell competitive bid contract, pursuant to Sections 2-797(3) of the Code of Ordinances.

Section 2: The purchase and installation of an artificial turf field is funded under the Infrastructure Surtax/Parks and Recreation/Infrastructure Account No. 101-7201-572-63.

Section 3: The City Manager is authorized to execute any necessary documents and budget transfers or amendments, associated with this purchase, upon consent of the City Attorney's office.

Section 4: This Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
