

RESOLUTION NO. 15-\_\_

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE CITY MANAGER TO AWARD AND EXECUTE THE CONTRACT TO THE LOWEST BIDDER FOR PROFESSIONAL ENGRAVING SERVICES AS PART OF THE SIDEWALK POETRY PROJECT INITIATED BY THE KEY WEST ART IN PUBLIC PLACES (AIPP) BOARD; AUTHORIZING THE CITY MANAGER TO EXECUTE THE NECESSARY DOCUMENTS; AUTHORIZING THE EXPENDITURE OF FUNDS FROM THE AIPP ACCOUNT; AUTHORIZING THE NECESSARY BUDGET ALLOCATIONS; APPROVING THE PROPOSED LOCATIONS OF SIDEWALK POETRY; AND RECOGNIZING THE PRIVATE FINANCIAL DONORS TO THE PROJECT; PROVIDING FOR AN EFFECTIVE DATE

**WHEREAS**, the Key West Art in Public Places ("AIPP") Board was established to advise the City Commission in the selection and location of public art in the City; and

**WHEREAS**, pursuant to Section 2-486 of the Code of Ordinances of the City, the AIPP Board may commission public art after approval of the City Commission; and

**WHEREAS**, the City Commission desires to promote art in public places through the Sidewalk Poetry project as proposed by the AIPP Board; and

**WHEREAS**, the City Commission wishes to recognize the financial contributions of private donors, who were invaluable in helping complete the project.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:**

**Section 1:** That the Key West City Commission:

A. Authorizes the City Manager to award and execute the contract for professional engraving services to the lowest bidder as part of the sidewalk poetry project initiated by the Key West Art in Public Places (AIPP) Board;

B. Authorizes the City Manager to execute the necessary documents;

C. Authorizes the expenditure of funds from the AIPP public art account;

D. Authorizes the necessary budget allocations;

E. Approves the proposed locations of sidewalk poetry, subject to minor changes (see attached); and

F. Recognizes the private financial donors to the project.

**Section 2:** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
