MINUTES

CITY COMMISSION MEETING

OLD CITY HALL, 510 GREENE STREET

TUESDAY, SEPTEMBER 7, 2010

A regular meeting of the City Commission of the City of Key West, Florida was held in Commission Chambers, Old City Hall, on Tuesday, September 7, 2010.

Mayor Craig Cates called the meeting to order at 6:00 p.m.

Answering roll call were Commissioners Barry Gibson, Teri Johnston, Clayton Lopez, Billy Wardlow, Jimmy Weekley and Mayor Craig Cates.

Commissioner Mark Rossi was absent.

Also present were City Manager Jim Scholl, Assistant City Manager David Fernandez, Assistant City Manager Mark Finigan, City Attorney Shawn Smith, City Planner Amy Kimball-Murley, Police Chief Donie Lee, Fire Chief David Fraga, Division Chief of Operations Michael Davila, Division Chief/EMG Management & Training Craig Marston, Community Services Director Greg Veliz, Utilities Manager Jay Gewin, Parking Manager John Wilkins, Senior Project Manager Doug Bradshaw, Senior Property Manager Marilyn Wilbarger, Senior Deputy City Clerk Sue Harrison and City Clerk Cheri Smith.

Reverend Sinclair Forbes, of Bethel AME Church, gave the invocation.

The pledge of allegiance to the flag of the United States of America was given by all present.

CHANGES TO THE AGENDA

City Manager Jim Scholl stated the applicant for Resolution Item 22 had requested a postponement until December 7, 2010.

Commissioner Johnston asked that Item 10 be removed from the Consent Agenda for discussion and clarification.

Without opposition, the agenda was accepted as changed.

PRESENTATIONS:

City Attorney's Report

The City Attorney had no report for the Commission.

Commissioner Johnston asked if they were still on track with the Assisted Care Facility. Mr. Smith responded he had forwarded an email from the group to the Commission and they were moving forward to select a provider. He would keep them up to date on the progress.

City Manager's Report

City Manager Jim Scholl updated the Commission regarding the vegetation to be used on North Roosevelt Boulevard after the FDOT work is completed.

Commissioner Johnston asked for an update to maintain the Coconut Palms. He would provide that information.

Mr. Scholl reported on the Truman Waterfront Development process and the marina. He stated the conflict of use had been resolved. Mr. Scholl reported on a meeting held on September 3, 2010 with the Monroe County staff, the County Administrator, County Attorney, Assistant County Attorney and the Executive Director of the TDC regarding the City's request for an Attorney General opinion and other issues on TDC funding.

Commissioner Gibson asked City Attorney Smith if he knew what the time frame would be if they did make a request for an Attorney General opinion. Mr. Smith responded that it could be thirty days. He stated he was not convinced the Attorney General will issue an opinion to the City as they are not the body that controls the funds. He said he watched the County meeting and three County Commissioners indicated the City Commission should seek the opinion because it has a significant stake

in the revenues that are generated in the City. He asked for direction to go ahead and seek the opinion from the Attorney General so they can have a clear signal on what is or is not permissible.

Commissioner Weekley wanted to see the City start planning for a park and make adjustments to the plan that had been approved.

The Commission agreed the City Attorney should seek the Attorney General opinion on the funding source and the sunset issue with the ordinance.

Commissioner Gibson requested the City Manager provide a timeline for approval.

Commissioner Lopez concurred with Commissioner Weekley. He stated he had an item to be presented on September 21, 2010 by resolution to move ahead with something on the Truman Waterfront parcel.

City Manager Scholl would see what he could bring back for them on September 21st with regard to a timeline.

Mayor Cates asked if the developer was prepared to finance the project themselves or would they rely on the County's funding. Mr. Scholl stated they could fund the project by different means but he would provide more detail in that regard.

The City Manager continued reporting they had a fourth public meeting of the Bahama Village / Truman Annex connectivity proposal on September 1, 2010. The final presentation was well received.

Mr. Scholl reported there had been a meeting on the Glynn Archer School property and on September 21, 2010 they will have a framework to look at for a potential agreement with the School Board for acquisition of the property. The School Board would look at the item after that at their meeting on September 28, 2010.

Mr. Scholl reminded the Commission that on September 14, 2010 at 6:00 p.m. they would have the first public hearing on the proposed budget for the next fiscal year and the next meeting to formally adopt the budget would be September 23, 2010 at 6:00 p.m., both meetings held at Old City Hall.

Commissioner Johnston asked the City Manager about the soccer fields. Mr. Scholl said the HOB soccer field would not be available for use due to the construction of the new school at the location. He did say Dr. Burke had promised all of the athletic facilities would be available to support the soccer leagues during the disruption at HOB. They are committed to relocating all the matches that would have taken place there to other properties. The field should be returned to athletic use after construction of the school. There is also a commitment to place soccer fields at Poinciana School.
